OSHA Begins Full Silica Enforcement

Via email, we reminded members that OSHA began full enforcement of its Respirable Crystalline Silica in Construction Standard on October 23, 2017. The email included a statement from AGC of America CEO Steve Sandherr, along with a "Silica Story." In addition, AGC sent members information detailing AGC's legal efforts to counter the regulation and the education materials AGC has assembled to assist with compliance. OHSA Announces Top 10 Violations

In late September, OSHA announced the preliminary list of 10 standards most frequently cited during FY2017. As it has for seven years, Fall Protection made the top of the list, followed by Hazard Communication, Scaffolding, Respiratory Protection, Lockout/Tagout, Ladders, Powered Industrial Trucks, Machine Guarding, Fall Protection Training Requirements (the only new addition to the list) and Electrical Wiring Methods.
